

A Special Rate of 6/3 per 1,000 cubic feet is charged for Gas supplied through a Separate Meter for a Gas Cooking Range or Gas Engine, with a Minimum Charge of 5/- per quarter.

All Installations will be inspected and tested and must prove satisfactory to an Officer of the Company before the Gas is turned on.

In the event of any additional light being used before it has been tested and passed by an Officer of the Company, the whole of the installation may be cut off until such test has been made and proved satisfactory.

Consumers entering upon or leaving premises without giving notice at the Company's Office will be held responsible for all Gas supplied to date of Meter Inspection. The intending consumer, before using Gas in new premises, is required to sign the usual form of application.

### TERMS AND CONDITIONS.

A Special Rate of 6/3 per 1,000 cubic feet is charged for Gas supplied through a Separate Meter for a Gas Cooking Range or Gas Engine, with a Minimum Charge of 5/- per quarter.
